- Meets and instructs assigned classes in the locations and at the times designated.
- Creates a classroom environment that is conducive to learning and appropriate to the maturity and interests of students.
- Plans a program of study that, as much as possible, meets the individual needs, interests, and abilities of students.
- Prepares for classes assigned, and shows written evidence of preparation upon request of immediate supervisor.
- Develops and delivers engaging, standards-aligned lessons in business and economics, including topics such as entrepreneurship, personal finance, and marketing.
- Employs instructional methods and materials that are most appropriate for meeting stated objectives.
- Observes, assesses, and evaluates students' performance regularly, and provides progress reports as required.
- Proficiency in using technology to enhance instruction and engage students.
- Ability to build strong relationships with students, colleagues, and parents.
- Establishes and enforces rules for behavior and procedures for maintaining order among the students for whom they are responsible
- Participates in curriculum development and maintenance
- Proven ability to integrate real-world applications and hands-on learning experiences into the classroom.
- Knowledge of financial literacy curriculum and resources.
- Ability to develop community partnerships and connect students with real-world business opportunities.
- Facilitate opportunities for students to participate in extracurricular activities such as DECA, FBLA, or similar business-related organizations.
- Perform other duties as assigned.
