Primary Responsibilities:

The Head Custodian is responsible for the overall maintenance and cleanliness of the school. It is their responsibility to ensure that the facilities are maintained in a condition of cleanliness, and safety. They also have supervisory responsibility over the other custodians including seasonal custodial employees. They must be able to perform a full range of general cleaning operations throughout school facility, such as clean floors; walls; fixtures; restrooms; cafeteria and gym areas and other assignments as specified by supervisor(s). Other duties as assigned

Qualifications: Knowledge of custodial procedures; read and follow instructions; good communication skills with co-workers and public; operate custodial equipment. Physical ability to exert 50-100 lbs. of force; strenuous walking, standing, climbing, and heavy lifting and carrying. Work outside and inside with exposure to hot and cold temperatures; and exposure to dust, toxic chemicals and materials.

Education/Training/Experience: High School diploma or G.E.D., and related job experience.

Terms of Employment: Full-time; twelve-month employee; compensation and benefits as provided by the Board of Education.
